We also assist in dispute resolution concerning immigration and provide representation in an immigration case in the Court of Law.

## THE FIRM'S BILLING SYSTEM

Billing by advocates in Tanzania is governed by the Advocates Remuneration Order, 2015 save for some matters which do not fall under the Order. Therefore, the firm's policy of billing its clients is commendatory and is tailored to suit our client's needs. Our approach is both flexible, adjustable, and transparent and the funds are accounted for at the end of each assignment. The firm usually requests a reasonable deposit in advance at the commencement of the assignment to enable it meet various disbursement as required to facilitate the assignment.

We have three methods for charging legal fees depending on the nature of the assignment given to us by a client.

- I. Time Charge
- II. Percent Charge
- III. Agreed Fees
- IV. Statutory Fees

#### I. TIME CHARGE

This is a charging method whereby an assignment given to our lawyer is billed in accordance with the time spent. A standard fee of equivalent to 150 US Dollar per Hour is being charged exclusive of disbursement fees such as fees paid to the government or other authorities in connection with the said assignment, telephone or fax charges, etc. This method applies to all kind of assignments in exception to litigation assignments.

## II. PERCENT CHARGE

This kind of charge applies mostly to Debt collection and Tax assignments which is 10% of the tax saved upon our intervention and 10% or more (negotiable) for debt collection assignment depending on the nature and amount of debt. This is also exclusive of the litigation charges.

#### III. AGREED FEES

Legal fees for preparation of legal instruments such as contracts, agreements, conveyances, deeds or other instruments, may be determined by mutual agreement between the Firm and the client before commencement of the assignment.

#### IV. STATUTORY FEES

This is kind of charge as according to the Advocates Remuneration Order. All assignments that involve litigation and other assignments stipulated in the Order are billed in accordance with the Order which prescribed a descending scale of fees from 10% to 3% depending on the value of the subject matter.
